**PLEDGE OF ALLEGIANCE:** Nate Konkel led the group and called the meeting to order at 1:03 p.m.

- : Review Comprehensive Plan with Penny Simonsen, East Central Regional Development Commission (ECRDC)
  - Simonsen gave an introduction of the members, grants, survey results, and welcomed guest presenters Brian Masterson and Angela Grochowski from HF School District.
  - Masterson provided information about enrollment fluctuation, boundary restructuring, open enrollment choices, upgrades happening, charter-home schooling, gated playground access, ball field access, extreme need to childcare and affordable housing, need for volunteers, communication challenges and expenses.
  - P & Z members discussed the need and benefits for signage of events happening at HF School,
  - Angela Grochowski spoke of the open gym opportunity, use of the baseball field by youth, pickle ball court upgrade funded by the Finlayson/Giese Lions (not yet completed), explained why there is no Jaguar newsletter or community education fliers (expenses and use of digital). P&Z discussed adding some school/community events to the City of Finlayson website. Masterson and Grochowski left the meeting at 2:10 p.m.

These goals relate to the entire community and involve any areas that are considered maintained parks or where no development exists.

- The group discussed where the current and past open spaces and parks exist or were.
- · They voiced opinions of the pros and cons of parks and open spaces.
- Koets stated to keep Goal I Policy: 1b from the 2004 Comprehensive Plan as stated.
  - 1b. Require that plans for each new residential subdivision include provisions for the reservation of sufficient open space to serve the needs of the anticipated population, either through park dedication or cash-in-lieu of land (money that is paid to the city when a developer is unable or unwilling to provide park/open space in a development and is usually used to maintain or expand existing parks/open space to accommodate the growth in use caused by the new development).
