

ORDINANCE NO. 02-01

CITY OF FINLAYSON, MINNESOTA

**AN ORDINANCE ESTABLISHING USE AND RATE
REGULATIONS FOR MUNICIPAL
WASTEWATER TREATMENT FACILITIES**

Ordinance No. 02-01 was adopted by the City Council of the City of Finlayson on April 8, 2002. The following official summary of Ordinance No. 02-01 has been approved by the City Council of Finlayson, Minnesota, as clearly informing the public of the intent and effect of the ordinance:

An ordinance regulating the use of and establishing a charge system for public and private sewers, establishing methods for a sewer service charge system, and providing penalties for violations of the regulations herein defined.

Summary of Ordinance

This ordinance provides for the following:

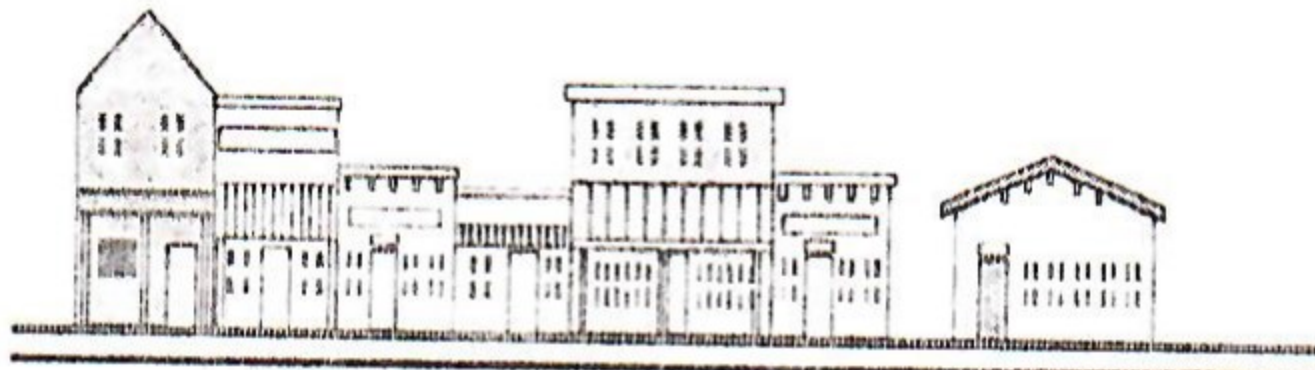
1. Control and general supervision of the sewage treatment system by the City Public Works Department.
2. Sets regulations governing types of wastes that should be discharged to the sanitary sewer system.
3. Sets regulations governing types of wastes that may not be discharged to the sanitary sewer system.
4. Sets regulations governing mandatory connections for all users adjacent to sewer system.
5. Sets regulations for wastewater disposal for users that are not adjacent to sewer system.
6. Site regulations governing new connections to the sewer system.
7. Sets regulations governing licensing of persons making new connections to sewer system.
8. Sets regulations governing the discharge of industrial wastes into the sewer system.
9. Provides penalties for persons damaging sewer system.
10. Provides for sewer service charges to recover costs associated with operation, maintenance and replacement of wastewater treatment system.

11. Provides for method of determining the sewer service charges.
12. Provides that each user shall pay applicable sewer charge.
13. Provides for penalties for non-payment of sewer service charges.
14. Sets regulations governing the power and authority of the City personnel.
